

PHYSICIAN PRACTICES HIE SERVICE PACKAGES



There are two packages of health information exchange (HIE) services available for your practice.

If your practice uses an electronic health record (EHR), and you prefer to have HIE data route seamlessly into your EHR system, you should choose the "integrated" package.

If your practice does not have an EHR, or if you have an EHR but would prefer to access HIE data from a stand-alone Web portal, you should choose the "standard" package.

Your practice's total cost for HIE includes a one-time implementation fee and recurring monthly subscription fees. For practices using an EHR, be aware that some vendors charge a fee to build or maintain an "interface" connection to an HIE. Please contact both CORHIO and your EHR vendor to confirm your total costs.

Implementation

This is a one-time fee that includes HIE training for your practice's staff. Fees are based on practice size.

Monthly Subscriptions

These are recurring monthly service fees for use of the HIE. Fees are per provider and based on work status.

Work Status	Integrated HIE Package (EHR integration + PatientCare 360 ^o ™)	Standard HIE Package (PatientCare 360 ^o ™ Web portal only)
Full Time Providers (25 or more hours/week avg.)	\$85	\$45
Part Time Providers (Less than 25 hours/week avg.)	\$45	\$25
Volunteer Providers (For community health clinics, FQHCs, etc.)	\$20	\$10

Important notes:

- A "provider" is defined as a physician (MD or DO), a physician assistant (PA), a nurse practitioner (NP) or a certified nurse midwife (CNMW).
- Office staff members are provided access to HIE tools at no additional cost. Staff are also included in training at no additional cost.
- Subscription fees do not begin until implementation is complete and data is being exchanged in the HIE.
