



Full Calendar Year Clinical Quality Measure Requirement

Many participants may not realize that the requirements for Clinical Quality Measure (CQM) reporting has changed from a continuous 90 days to a full calendar year (CY). Here is more information and a few tips to help you successfully meet the CQM reporting requirements.

Since this is the first time CQMs have been a full CY, the MAPIR system isn't set up to differentiate between the continuous 90 days for Meaningful Use (MU) and what is needed for CQM reporting. Please select the continuous 90 days for MU option in the MAPIR system (see screenshot below).



Participants will need *two* dashboard reports to meet MU requirements for Program Year (PY) 2018. The first dashboard must report a continuous 90 days in CY 2018 for *all* objectives. The second dashboard report must be a full CY for CQMs.

It is imperative to enter all data correctly into the MAPIR system. Please enter the data for objectives from your dashboard report for the continuous 90 days and followed by the CQM data (numerator/denominators) from the full CY dashboard report.

Remember, you will need to upload both dashboard reports in to the MAPIR system to support your attestation.

Program Year 2018 attestations are coming in strong. The MAPIR system has already received 210 attestations.

Program Year 2018 Deadline

The MAPIR system will close on June 7, 2019 for Program Year 2018 attestations.

New Webinars to Assist with Attestations

Supporting Your Attestation with Documentation

Many eligible professionals have questions on how to support their MU attestation with documentation. The following list will help participants know what to upload into the MAPIR system.

- Dashboard report from Electronic Health Record (EHR) system (continuous 90 days)
- Second dashboard report from EHR system for CQMs (90-days for first time attesters a full CY for all others)
- Security Risk Analysis report
- Clinical Decision Support (CDS) (identify which 5 CDS are enabled in the EHR and provide time-stamped screen shots/prints)
- Clinical Decision Support (identify which 4 CQMs)
- Drug-Drug (screen shots/prints) **and** Drug-Allergy (screen shots/prints)
- Dashboard reports
- Exclusion (if selecting an exclusion take screen shots/prints)
- Yes/No attestations answers (screen shots/prints, Public Health Agency letters, Clinical Data Registry letters, etc.)

Benefits to Medicaid Providers who Join the Health Information Exchange

CORHIO is encouraging Medicaid EHR Incentive Program participants to join by May 1, 2019 and get the first six months of fees waived for up to five providers for PatientCare 360®, a web-based portal including patient data from most major hospitals and labs in the state.

CORHIO can not only help deliver better patient care by providing access to patient health information from other providers but can also do the following:

- EHR Results Delivery: patient data from the ER or a hospital inpatient encounter is automatically routed into the appropriate providers' EHR in real-time
- Direct Messaging: simplified and highly secure version of HIE that works a lot like email
- CCD Exchange: following a patient encounter, your EHR generates a summary of care document (CCD), which is sent to the HIE
- Notifications: targeted patient-matched data services that help you stay better informed of recent critical events with your patients
