Last Minute Attestation Issues

Participants may have an incomplete attestation in the MAPIR system (also known as the Colorado Registration and Attestation website) for Program Year (PY) 2018. If you are not planning on completing your attestation, please login to MAPIR and abort the application so future program years will not be affected.

If an attestation is left incomplete in the system, the participant will not be able to begin their attestation for the next program year until the incomplete attestation is completed or aborted.

Many participants are experiencing login issues. If a User ID or Password has been forgotten, please make sure to use the [Forgot User ID](#) and [Forgot Passwords](#) links here or on the Provider Portal. All passwords used at the Provider Portal expire every 90 days. Please make sure User IDs and Passwords are available and secured by the proper personnel within the organization for future reference.

How to Track Your Submission

With the closing of Program Year 2018, many participants may be wondering about next steps. Participants need to track their submitted attestation to ensure everything has processed correctly. The MAPIR system sends out email communications to participants that, in turn, help track your submitted attestation. The language below is designed to help you know where your application is in the submission to approval process.

- Submitted Attestation — You will receive an email alerting you that the attestation has been submitted.
- Approved — You will receive an email stating you have been approved for a Medicaid EHR Incentive Program payment and to look for an Electronic Funds Transfer (EFT) payment or a paper check within two weeks.
- Email from Myers & Stauffer—Many participants, before being approved/not approved for payment, may be contacted by the Department of Health Care Policy and Financing's (the Department's) accountants for more information. (Please make sure to check spam/clutter folders for any communications from MAPIR or Myers & Stauffer LC.)
- Denied Attestation— If your attestation is denied, there may be several reasons. A denial is followed-up with the Department's correspondence containing an explanation why the attestation was denied. Participants who do not receive correspondence from the Department and have not been paid, need to contact the Medicaid EHR Incentive Program Coordinator at MedicaidEHR@corhio.org.

Congratulations to all the many participants that successfully attested to Program Year 2018!

Over 700 have submitted attestations with over \$720,500 in Medicaid EHR Incentive payments awarded.

The Role of Myers and Stauffer

To ensure appropriate and transparent payments to Medicaid EHR Incentive Program participants, the Department completes pre-payment reviews and post-payment auditing activities. All Medicaid EHR Incentive Program attestations are reviewed prior to payment, but only a percentage are audited post-payment. The Department contracts with Myers and Stauffer LC (MSLC) to perform pre-payment reviews and post-payment audits. Please look for communications from The Department's auditors, MSLC. These communication emails may get lost in spam, junk or clutter folders and participants should be vigilant in checking for them.

It is important to respond to MSLC's communications to avoid possible incentive payment recoupment. If you have received a communication email and have any auditing questions, please contact MSLC at coloradoehr@mslc.com directly, not the Medicaid EHR Incentive Program Coordinator.
